

## FISHER/NIGHTINGALE HOUSES, INC. EXECUTIVE BOARD


The first volunteer Board was formed shortly after opening the Nightingale House. It provided financial support and insured the future of the founders' dream for an affordable on base home-away-from-home for military families in medical crisis. In 1990 these dedicated founders, led by Captain Gretchen Lizza, established and became the first members of the Nightingale House Support Association, a private, non-profit charitable organization. This Board assisted in fundraising, staffing the house with volunteers and made all financial decisions.


The Board's sole mission is to raise funds to support compassionate care lodging for patients and their families receiving critical medical treatment at the Wright-Patterson Medical Center and the Dayton VA Medical Center. The Fisher Houses are owned, managed, and supported financially by the Air Force/Department of Defense (DoD) and the Department of Veterans Affairs. The Fisher/Nightingale Houses, Inc. donates funds to the Air Force/DoD and the Department of Veterans Affairs to support the guests and operations of the three Greater-Dayton areas Fisher Houses.

The partnership between the Board, the House managers, the volunteers and the Air Force/DOD and Department of Veterans Affairs has been essential to the success of the Wright-Patterson AFB and Dayton VA Fisher Houses. Together, we have accomplished great things – together, we are making a difference!

## Message from the Executive Director

Dear Friends,

This letter is one that I am honored to write. For those of you that I have not had a chance to meet yet, I am the new Executive Director of the Fisher/Nightingale Houses, Inc. (FNHI). In the Spring of 2023, a colleague shared a job posting with me, and told me that it appeared to him that the universe had created an opportunity to serve in a role that blended three areas that I value deeply. It was a turning point for me, as I began to learn about the compassionate care that is provided by The Fisher Houses to our military and veteran families during time of medical treatment. I am a medical professional by training and have found very meaningful work throughout my career supporting non-profit organizations. And my deep respect and affection for those who have served and are serving our country is a core value that I hold dear. Upon joining the FNHI team, I found a very supportive Board of Trustees and Advisors, a strong foundation of support from the partners and stakeholders in the region, and a deep commitment to this organization demonstrated by The Fisher House Foundation.

The Fisher House Foundation builds comfort homes where military and veteran families can stay free of charge while a loved one is in the hospital. These homes are located at military and VA medical centers around the world. The Fisher/Nightingale Houses, Inc. is a 501(c)3 that supports the three Greater-Dayton area Fisher Houses. There are two houses located on Wright-Patterson Air Force Base, and one located at the Dayton VA Medical Center. Collectively, they house 37-bedroom suites, which provides a total of 13,505 nights of lodging for their guests annually. The monies raised by the Fisher/Nightingale Houses, Inc. directly support the guests and operations of the three Greater-Dayton area houses.

As you peruse this report, your heart will be touched by the stories of the guests highlighted within these pages. Through their own words, these families describe the profound impact the support and care afforded to them through the Fisher Houses. There is a common phrase that is often seen in connection with Fisher Houses: "Because a family's love is good medicine." Having a support system while undergoing medical treatment has been proven to promote healing and recovery. At times, the patient may not recover. To quote a family member of one of the guests of the Fisher Houses in Greater Dayton in 2023 upon the passing of their son: "He may not have healed the way we had hoped he would, but we began to, as a family, because we were able to be here together." To highlight the positive contribution of our Greater-Dayton area Fisher Houses, we have chosen the theme, "Compassionate Care Heals" for our annual gala, this year being held on May 18th at Sinclair Conference Center. This annual report demonstrates a robust financial picture for Fisher/Nightingale Houses, Inc. This is directly due to the generous support that we receive from individuals, organizations, and corporations alike. Donations come in monetary form, as well as in-kind from partners throughout 2023 that found us accepting shampoo, water, cookware, pillows and sheets, mops and vacuums, and everything in-between. Regional partners named us as a charity to donate round-up to the nearest dollar programs, and grants were given to support projects like the whole-house generator that is being installed at the Dayton VA Fisher House. Volunteers came by with hand-made afghans. Churches, AmVets posts, and other organizations named us as a recipient of activities to raise funds through auction items, golf outings, poker runs, the list goes on and on. The generosity for FNHI that helps us to continue to serve those who have served us all is in a word, overwhelming. We are grateful. We are also committed to being good stewards of all these gifts, and once again have earned a four-star rating with Charity Navigator, and a Platinum Transparency rating with Candid.

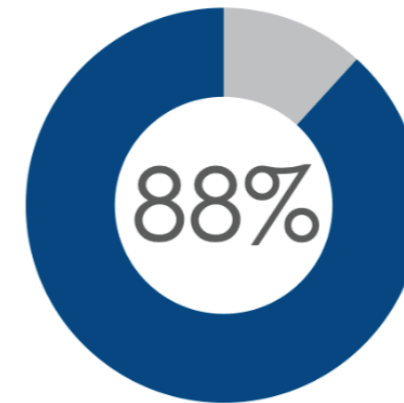

Percentage of income spent

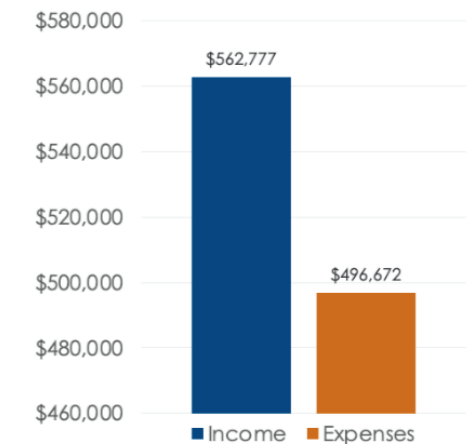

In the middle of 2023, one of the two Fisher Houses at Wright-Patterson Air Force Base was taken off-line for scheduled updates to the kitchen and all bathroom units. Under the direction of House Manager, Diyor Nishanov, the second Fisher House there continued to serve the guests, and the construction for the first house is right on track. They served 179 new families and had a total of 297 families accommodated in 2023. There were 1,796 occupied guest nights for the year with an average stay of 4.9 days. One particular guest stays less than the average number of days per visit, but has the distinction of being the only guest at the base that has stayed in the original Nightingale House, which was housing available prior to the construction of the Fisher Houses, and then at both Fisher House I and Fisher House II. Betty Franklin has been coming to the hospital on the base for nearly three decades after a diagnosis in the early 1990s. Often, Mrs. Franklin comes on a monthly basis, coming now from several hundred miles away to continue her care with her medical team, driven by her husband Herbert, a retired Air Force Veteran. The Fisher Houses share a goal, which is to be a “Home Away From Home.” Betty describes her time at the compassionate care houses as one where you are part of the family. She states, “The Nightingale House, the Fisher Houses, and the care of the team at the hospital have made my cancer journey much more bearable. I simply couldn’t have asked for anything better.” She and her husband enjoy their family, which now is five generations strong.

**FAYE AND LEO HEATLEY**

“It’s been a godsend. I don’t know what I would’ve done.” – Faye Heatley

Leo Heatley is an 88 year-old Navy veteran who lives in Osprey, Florida. He and his wife, Faye, were travelling from their home to their cabin in Michigan in early September, 2023. Leo was driving, and they decided to stop in Tipp City for the evening to rest. After checking into the hotel, Leo went out to take a walk. When he didn’t return, and didn’t answer Faye’s phone calls, she panicked. Her fears were realized when the Tipp City Police knocked on the door. Leo had been struck by a car in a crosswalk, and was seriously injured. Faye reported that she didn’t even recognize him at the hospital and was in a state of shock, unsure what to do or where to go. To quote Faye, “And then this angel appeared—a social worker—and she told us about the Fisher House. And it’s been a godsend. I don’t know what I would’ve done.” Leo had to remain in the hospital for weeks, and had intensive physical therapy. During that time, Faye and Leo’s children came to visit and stayed as guests as well. Because of the support of the Fisher House, Faye was with her husband every step of the way. They were able to return home a few days before Thanksgiving, and Leo is expected to make a full recovery. Quoting Faye once again, “If I couldn’t have stayed here, I don’t think he would have made it.”
